

2. Shareholder Advocates, LLC is authorized to take any actions on behalf of U.S. Wireless Online, Inc, pursuant to NRS 78.347 that are reasonable, prudent, or for the benefit of U.S. Wireless Online, Inc., including but not limited to issuing new shares of stock and issuing new classes of stock.

3. Pursuant to NRS 78.347(3)(a), Shareholder Advocates, LLC, shall comply with NRS 78.180 to reinstate U.S. Wireless Online, Inc.
 4. Shareholder Advocates, LLC shall provide reasonable notice to all shareholders of record of a shareholders meeting that will be held within a reasonable time after this Order is entered.
 5. Shareholder Advocates, LLC, as custodian of U.S. Wireless Online, Inc., shall submit a report to this Court of the actions taken at said shareholders meeting.
 6. Shareholder Advocates, LLC shall report to this Court every three (3) months concerning its custodianship of U.S. Wireless Online, Inc., while such custodianship remains active.
 7. Shareholder Advocates, LLC shall, pursuant to NRS 78.347(4), file an amendment to the Articles of Incorporation of U.S. Wireless Online, Inc., with the Secretary of State containing the following disclosures and statements:
 - a. Disclosures of any previous criminal, administrative, civil or National Association of Securities Dealers, Inc., or Securities and Exchange Commission investigations, violations, or convictions concerning Shareholder Advocates, LLC, or its affiliates or subsidiaries.
 - b. A statement that reasonable, but ultimately unsuccessful, attempts were made to contact the officers or directors of the corporation to request that U.S. Wireless Online, Inc., comply with corporate formalities and to continue its business.
 - c. A statement that Shareholder Advocates, LLC, is in fact, continuing the business and attempting to further the interests of the shareholders.
 - d. A statement indicating that Shareholder Advocates, LLC will reinstate or maintain the corporate charter.


